FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 10

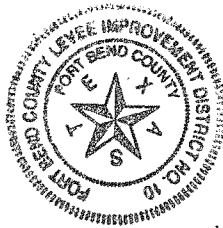


1. Operations and service requirements relating to COVID-19 epidemic and ratification of any emergency actions, if necessary.
