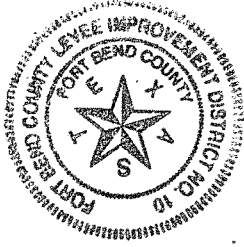
FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 10


The Board of Directors of Fort Bend County Levee Improvement District No. 10 will hold a regular meeting on Thursday, March 26, 2020, at 11:30 a.m., by teleconference* at (888) 251-2909, Access Code: 7514291 to discuss and, if appropriate, act upon the following items:

1. Declare emergency.
2. Consider operations and service requirements relating to COVID-19 epidemic; Memorandum regarding preparation for potential effects of COVID-19; and adopt Resolution Regarding Delegation of Authority Due to an Emergency.
3. Public comments.
4. Approve Minutes.
5. Phase II MS4 Storm Water Management Plan implementation.
6. City of Sugar Land matters, including rain gauge installation.
7. Annual Review of Procedures for Continuing Disclosure Compliance.
8. Report from Lake Management Services, including billings, repairs, maintenance and approve proposals, as necessary.
9. Series 2020 Unlimited Tax Park Bonds, including adopt Resolution Authorizing Application to the Texas Commission on Environmental Quality for Approval of Project and Bonds.
10. Financial and bookkeeping matters, including payment of bills, review of investments, amend budget, and amend agreement for bookkeeping services.
11. Tax assessment and collection matters, including payment of tax bills, delinquent tax collections, and installment agreements.

 - a. approve plans and specifications and authorize advertisement for bids for repairs of District facilities, including backup motorized sluice gates and site access improvements for District pump station;
 - b. channel erosion matters; and
 - c. deeds and easements.
13. Capital Improvement Plan.
14. Resolution in Support of Project Brazos.
15. Operation of District facilities, including:
 - a. billings, repairs, maintenance, approve proposals; and
 - b. Brazos River erosion status and repairs.

18. Reports from Director and/or District consultants regarding additional District matters.
