

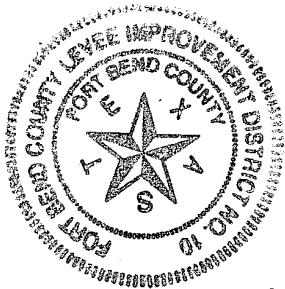
## NOTICE OF MEETING

### FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 10

The Board of Directors of Fort Bend County Levee Improvement District No. 10 will hold a special meeting on Tuesday, January 9, 2024, at 9:00 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, Neches Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve Minutes.
3. Annual Report regarding Post-Issuance Compliance Policy.
4. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, public comment, and approval of annual report and public education materials.
5. City of Sugar Land matters, including Hog Taskforce.
6. Report from Lake Management Services, including billings, repairs, maintenance, and proposals, as necessary.
7. Consider amending Landscape Maintenance Agreement Between the District and Riverpark on the Brazos Property Owners Association, Inc.
8. Financial and bookkeeping matters, including:
  - a. payment of bills and review of investments;
  - b. accept annual disclosure statements for Investment Officer and bookkeeper; and
  - c. amend budget, if necessary.
9. Tax assessment and collection matters, including payment of tax bills, delinquent tax collections, and installment agreements.
10. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, approval of pay estimates, change orders, and/or final acceptance, construction related consultant proposals, and direct engineer to notify insurance company of new facilities, if appropriate, for the following:
  - a. Channel erosion matters;
  - b. Deeds and easements;
  - c. Park design projects, including:
    - i. Park at the Levee (Enclave); and
    - ii. Overlook Trail Extension; and
  - d. Capital Improvement Plan.
11. Operation of District facilities, including billings, repairs, maintenance, and approve proposals.

12. Park land substitution with City of Sugar Land for ongoing park and recreational projects, including approve agreement between the District and RiverPark on the Brazos Property Owners Association, Inc.
13. Park and recreational facilities matters, including:
  - a. update regarding playground inspections and park projects;
  - b. purchase facilities or authorize repair of District park facilities; and
  - c. design of new park facilities.
14. Perimeter levee matters, and membership and attendance for regional and federal levee and flood fighting conferences, including National Association for Flood and Stormwater Management Agency, FBEDC FBFMA Committee, and Association of Water Board Directors.
15. Reports from Directors and/or District consultants regarding additional District matters.
16. Approve and authorize filing of education/training compliance status for Board of Directors with the Fort Bend County Drainage District.
17. District website matters.
18. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer.
19. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation, or a settlement offer.
20. Honoring Directors and their Service.
